I, the undersigned, authorise StaffChecks (the trading name of StaffChecks Vetting 1 Ltd) ("SVL") and its duly authorised agents, to collect, retain and disclose personal information about me in accordance with the following:

1. **Any personal information that is** collected and retained by SVL and subsequently disclosed by SVL (as set out below) will only be used for the sole purpose of evaluating my suitability for employment with the Company and any company or organisation that I apply for employment with in the future.
2. **The information collected may include** all or any of the following:
 - Credit record;
3. **Information may be collected from all or** any of the following agencies:
 - Police;
 - Baycorp Advantage
 - LTSA;
 - Department of Courts;
 - Work and Income New Zealand;
 - New Zealand Immigration Service;
 - Educational Institutions;

and such other sources which may hold necessary information including, but not limited to, referees, current and previous employers and individuals or organisations with which I am or have been associated.

As part of the Credit check you give the consumers information to Baycorp Advantage. Baycorp Advantage Collects that information and uses it to update its credit reporting database for use by other credit providers.

4. **The information will be disclosed to the** Company named above and only used by it for the sole purpose of evaluating my suitability for employment with the Company.

5. **The information will also be collected** and retained indefinitely by SVL, and used and disclosed by SVL to any company or organisation that I apply for employment with in the future, if that company or organisation requests SVL to disclose the information to it. That company or organisation will only use the information for the sole purpose of evaluating my suitability for employment with it.

6. **If I am offered and accept employment** with the Company, but I am subsequently found by the Company to have committed an act of dishonesty in my employment with the Company, or I am dismissed by the Company for serious misconduct (the "Incident"), then I authorise the Company to disclose to SVL, and SVL to collect and retain, details of the Incident. I also authorise SVL to disclose details of the Incident to any company or organisation that I apply for employment with in the future, if that company or organisation request's SVL to disclose the information to it. That company or organisation will only use the information for the sole purpose of evaluating my suitability for employment with it.

7. **I may obtain access to** (and request the correction of) any information about me that is held by SVL (PO Box 271, Auckland, Ph 0800782 332), at any time, subject to any right that SVL has to refuse me access on the grounds that the information constitutes "evaluative material" (as defined in the Privacy Act 1993) or as otherwise provided for by the Privacy Act 1993.
