# **FUND UPDATE**

# The Presbyterian Church of Aotearoa New Zealand Beneficiary Fund- Growth Fund for the year ended 30 June 2018

This fund update was first made publicly available effective 28 September 2018.

#### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Growth Fund ("the fund") has performed and what fees were charged. The document will help you to compare the fund with other funds. The Presbyterian Church of Aotearoa New Zealand Beneficiary Fund Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

#### **DESCRIPTION OF THIS FUND**

The Growth option invests mainly in growth assets such as shares and real assets. This option may be suitable for investors wanting to invest mostly in growth assets who are comfortable accepting more fluctuations in the value of their retirement savings than those expected from the Balanced option with a view to achieving higher longer-term returns.



#### WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the fund:


#### **EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR**

Michael had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Michael received a return after fund charges were deducted of \$276.00 (that is 2.76% of his initial \$10,000). No other charges were deducted. This gives Michael a total return after tax of \$276.00 for the year.


