## 1 Updated Treasurers Manual

### 2 Year End accounts

A draft of the General Assembly accounts to 30 June 2008 has been prepared and is in the process of being audited prior to signing off by the convenors of the Council of Assembly. Detail cannot be released at this stage however the results shown are a continuation of the positive financial performance and position trends of the past few years. The report will be released to the Church prior to General Assembly in October.

## 3 Insurance invoicing

Parish and schools in the Presbyterian Insurance Group will receive invoices for premiums for the 2008-09 insurance year in the next week or so. The Insurance Group are required to pay the insurance brokers, AON in September so prompt payment of the parish invoices is appreciated. Loyalty and prompt payment discounts apply.
