1. PCANZ Annual Accounts to 30 June 2015


The audited financial report for General Assembly has been signed off by Council of Assembly and is posted on the Church website:

The accounts are summarized, along with an overview of activities and an explanation of the use of Assembly Assessment. A table of income and expenditure by function with budget comparisons is displayed in the appendix. Please contact me if you require further detail.

Summary: General Assembly Financial Accounts

Operating Income for the year to 30 June 2015.



Assembly Assessment is set by the Resource Sub - committee of the Council of Assembly at the beginning of each financial year and is calculated on the reported income and membership of each church. The levy is currently set at 6.8% of the total income of all Presbyterian churches. When adjusted for the Ministers beneficiary fund component of AA expenditure, that proportion is reduced to 4.1%.

Throughout 2014-15, the average church was levied about \$11,400 by Assembly Office (\$3,075,000 / 270 contributing churches). About 96% of billings had been collected by year-end.

Assembly Assessment does not directly contribute to all Assembly functions. For example Global Mission, donations paid and the operation of the Knox Centre are largely funded by, grants and donations received, interest on investments, and fees charged to parishes and schools. Presbyterian Foundation grants and expenditure relating to Press Go activities are almost entirely funded from interest income and the accessing of reserves.

On the other hand the Parish contribution to the Ministers Beneficiary Fund of \$1.3m is funded entirely by Assembly Assessment, and about \$1.8m of operating shortfalls for administration and local mission is funded by AA and Cooperating parish contributions.

Assembly Assessment is utilised as follows:

Cooperating Parish Contributions. This amount is set by Uniting Churches of Aotearoa New Zealand and is based on a proportion allocated to the Presbyterian Church from cooperating parish contributions to UCANZ. On a per-member basis the fees received from cooperating churches is similar to that collected by Assembly Assessment from Presbyterian parishes (adjusted for the Ministers Beneficiary Fund portion of AA. Cooperating parishes pay the church contribution directly to the Beneficiary Fund)


Grants and donations received. Total grants received were \$618,000. PCANZ continues to benefit from grants from the Synod of Otago and Southland for the Knox Centre and Presbyterian Research Centre operations, as well as grants received from Council of World Mission for Global Mission and Pacific Island Synod operations, and dividents from a farm managed by the Church Property Trustees. In addition donations received from church members and the public was \$377,000, mainly for Global Mission and the moderators appeal for disaster relief in Vanuatu.

Interest Income. This is interest earned on about \$22m in investments held in the Presbyterian Investment Fund and Baptist Savings. About 55% of this interest can be used as operating income and the remainder is allocated for specific mission and ministry purposes.

Property Income. PCANZ owns an investment property in Christchurch which generates rental income from a commercial operation. A June 2015 revaluation reported an increase of \$25,000.

Sundry Income. This includes sales and advertising in Spanz, registration income for General Assembly in October 2014, fees charged by Knox Centre for resourcing Presbyterian Schools, and administration fees earned by the Financial Services Department. In addition there was an insurance settlement that recovered some legal fees incurred in the prior year.

Operating Expenditure for the year to 30 June 2015.



The **Ministers' Beneficiary Fund** provides income for ministers' retirement. It is calculated at 9.7% of the basic stipend and supplements contributions made by each minister out of their stipend. This expense is funded entirely from parish contributions incorporated in Assembly Assessment.

Overseas Mission.

The Global Mission function of PCANZ supports partner churches, primarily in:

- Vanuatu, where PCANZ sponsors a missionary couple located in Talua
- Myanmar, through a collaboration with St Columba in Botany Downs (the Rice Bowl Fund)
- North India. PCANZ supports a hospital and schools, partly with funds that have been transferred from the Friends of Jagadhri support group.

In addition the Moderators appeal for disaster relief in Vanuatu generated about \$160,000 in donations. By the end of June, \$43,000 of this fund been used.

Governance covers the operations of the Council of Assembly and associated committee's primarily the Resource and Leadership sub-committees and the National Assessment workgroup. In addition there are Council led activities regarding Book of Order advice, complaints process, the personnel workgroup and ministry review process.

Knox Centre for Ministry and Leadership

The Knox Centre for Ministry and Leadership forms ministers and leaders for services in the Presbyterian Church. We work in partnership with a variety of groups and networks including Te Aka Puaho, the Pacific Island Synod, Asian Mission and congregations.

In addition to training people for National Ordained Ministry, Knox Centre also provides training for Local Ordained Ministers, Local Ministry Teams and other recognised ministries in the Church. We support presbyteries and congregations in their leadership development, and help resource continuing ministry formation among the Presbyterian Church's ministers and elders.

2. Mileage Rates Update

I have been advised by the Inter Church Bureau that vehicle mileage reimbursement rates for 2015-16 have been confirmed and are as follows:

- Up to 14,000 km annual running for all purposes reimburse work running at 71 cents (71 cents).
- Up to 20,000 km annual running for all purposes reimburse at 58 cents (58 cents).
- Up to 26,000 km annual running for all purposes reimburse at 51 cents (51 cents).
- For mileage beyond chosen band range reimburse at 28 cents (28 cents).
