Functions and responsibilities (key activities, task and outcomes to be achieved)

- In each area of the public hospital to which you have been appointed, your primary responsibility is to deliver appropriate and culturally sensitive Spiritual Healthcare. This will be achieved by engaging with multi-disciplinary teams to support identification of spiritual care need, visiting wards / units and following up requests for visits from patients and referrals from staff.
- This position will be .5FTE supporting patients with mental health illnesses within the designated mental health wards and services and in the general wards as requested by staff, the patient or the whanau.
- .5 FT working as a general hospital chaplain in the general hospital wards, services and departments.
- Respond to crisis calls, within the hospital including the Mental Health Unit if requested.
- Visit wards, units and attend appropriate meetings within the hospital as guided by your lead chaplain.
- Work as part of the care team within the facility and services allocated within your portfolio to enhanced understanding of the chaplaincy contribution to care and the effectiveness of multi-disciplinary team work.
- Conduct spiritual/religious services and rituals in the hospital.
- If requested or appropriate refer to other religious or spiritual leaders within the community.
- Train and supervise Volunteer Chaplaincy Assistants as guided by the Lead Chaplain.
- Assist the chaplaincy team and ICHC with other duties as required. This may include promoting hospital chaplaincy to groups in the wider community.
- Ongoing professional development as directed by your Regional Manager in consultation with the Lead Chaplain. This will include working towards to becoming an accredited chaplain.
- To record all your Chaplaincy activities in the designated MOH/RBA system in a timely manner

- A team player is critical for this position.
- Effective and personable communication skills, including a positive and respectful attitude towards others.

- Participate as a regular member in MDT and team meetings across the respective areas of focus to ensure a focus on spiritual care for patients.
- Current letter of ordination, accreditation, good standing or equivalent from your denomination.
- Good time management skills and a willingness to be an active member of the chaplaincy team.
- Experience in hospital chaplaincy, pastoral counselling or other relevant ministry.
- Good self-care and committed to regular monthly supervision by a professionally trained supervisor.
- Leadership skills and abilities, to support team working and development of services, whilst not essential will be viewed positively
- Appropriate Mental Health qualifications and experienced in pastorally supporting patients with mental health illness
- A current driver's licence.

- Computer literacy
